Personal Information Collection Statement 收集個人資料聲明

- 1) The personal data provided by you will be used by the Board for purposes relating to the statutory functions of the Board prescribed in Section 26 of the Pneumoconiosis and Mesothelioma (Compensation) Ordinance Cap. 360, Laws of Hong Kong, including but not limited to levy assessment purposes in accordance with the Pneumoconiosis and Mesothelioma (Compensation) (Assessment of levy) Regulations, conducting educational, publicity, research and other programmes to prevent pneumoconiosis and mesothelioma and conducting programmes for the rehabilitation of persons suffering from the above diseases.
